**AD Report:**

Open Gym – coaches want back in, follow same protocol? Thermometers are received. Dan Tramp weight lifting? Jason Page will talk with him. Practice August 10<sup>th</sup>. Colorado mask mandate begins tonight for inside of buildings. Protocol the same. Lengthy COVID discussion. FFA meeting tomorrow – be cautious have meeting outside if possible. Open Ag Door. Some state pushing back practice and game start dates, fall sports a go as of now. Some games not held. Passes ordered with CHSAA- 14 to place. Buses to Yuma, 2<sup>nd</sup> one went this week. Sports – some states are flipping the order of sport from spring to fall. Open gym transportation during fair week is a concern.

**Superintendent's Report:**

Kitchen – I spoke with Stacey about cleaning ovens, labeling food and rotation of stock. Out of date items were thrown away- many. Discussion on counter tops being changed out for stainless.  
CRF/ESSER Funds: technology, custodial, laptops & headsets, Document cameras -\$19,562.60 spent. Possibly looking to purchase more student laptops. Johnson controls for air filtration system – per room not overall. Gym- games will only be able to have so many in the gym., TV in kitchen camera that follows game. Touchless restrooms, automatic. Look into a grant to replace the plumbing. ESSER – transportation use ok. CRF salaries only for additional staff/instruction time March – May: running numbers to see how it affects budget. Spend CFR: 1<sup>st</sup>-Technology, 2<sup>nd</sup>-Automate, and 3<sup>rd</sup>-Salaries. Use daycare room for meetings. Cameras in rooms for distance learning. If Technology comes July/August, possible to change start date back a week to August 24<sup>th</sup>? This will give us time to learn all the new technology. Use snow days to prepare to teach differently this year. Consider count days – 1080 for high school- CDE backed off of online days can be counted as contact days. Custodial request to hire a fulltime custodian along with the part time position. Bus Routes- Ronda Peebles and Dan Tramp are going in to take their CDL test. Routes refigured to keep from crossing paths. Temperatures 1<sup>st</sup> by parents, Bus Aide? Or at school? Social distancing as much as possible. – Pay parents to transport?

Prefer to interview not appoint – find candidates from other schools, Bethune and Burlington may have some.




